### WHAT IS THE PRODUCT?

#### Type:

Share Class of the Sub-fund D-X MSCI World Screened UCITS ETF - Class X – issued by AILIS, an umbrella investment company with variable capital (société d'investissement à capital variable) incorporated as a public limited company (société anonyme) in the Grand Duchy of Luxembourg, qualifying as an undertaking for collective investment in transferable securities (UCITS) under Part I of the Luxembourg Law dated December 17, 2010. This Sub-fund is an Exchange-Traded Fund.

#### Term:

This sub-fund is not subject to any fixed term. The SICAV's liquidation shall be decided by the general meeting of shareholders, in accordance with the applicable law and the Articles of Incorporation. The Company may also enter into liquidation by judicial decision according to the Luxembourg Law of December 17, 2010. The Board of Directors may decide to liquidate the Sub-Fund in case of extraordinary events such as changes in the political, economical or monetary situation or when the net asset of the Sub-Fund is less than a minimum level for the Sub-Fund to be operated in an economically efficient manner, as further described in the Prospectus.

#### Objectives:

The D-X MSCI WORLD Screened UCITS ETF Sub-fund aims to track the performance of "MSCI World ESG Screened" Net Total Return, in USD converted in EUR (the "Index"), and to minimize the tracking error between the net asset value of the Sub-fund and the performance of the Index. The Index is designed to represent the performance of the Global large and mid-cap stocks.

The Index, published by MSCI Limited as benchmark administrator (the "Index Administrator"), is an equity index designed to represent the performance of global large and mid-cap stocks.

The Index measures the performance of a sub-set of equity securities which are part of the MSCI World Index (the "Parent Index") which excludes companies from the Parent Index based on the Index Administrator's ESG exclusionary criteria.

The Index is calculated and published by the Index Administrator. The Index rebalances on a quarterly basis without any additional costs for the Sub-fund. The Index methodology, composition, revision rules and additional information on the constituents are available on

The Index promotes Environmental and Social characteristics as well as best practices of Corporate Governance using MSCI ESG Business Involvement Screening Research to identify companies that are involved in the following business activities: -Controversial Weapons; -Nuclear Weapons; -Civilian Firearms; -Tobacco; -Thermal Coal; -Oil Sands.

The Sub-fund is passively managed and aims to track the performance of the Index through physical replication (i.e. direct replication), mainly by investing directly in all or a substantial number of the Index constituents.

Investable assets will include equity securities that promote Environmental, Social and Governance ("ESG") characteristics and may also include preferred stocks, warrants on equities and depository receipts such as American depository receipts (ADR), European depository receipts (EDR) and Global Depository Receipts (GDR).

The Sub-fund will invest primarily in securities that are listed or traded on Recognised Markets.

Direct investments, for liquidity management purposes, may include investment grade debt securities issued by governments, corporations or institutions, money market instruments and deposits with credit institutions without limit of duration or currency and will be limited to 10% of the Sub-fund's net assets. The holding of ancillary liquid assets is limited to 20% of the net assets. Under exceptionally unfavourable market conditions, and on a temporary basis, this limit may be increased up to 100%. The Sub-fund may use financial derivative instruments for the purpose of currency risk hedging and for investment purposes.

The Sub-fund will replicate the Index by holding its securities in similar proportions to their weightings.

In selecting the representative sample of the constituents of the Index, the Investment Manager will use techniques such as Stratified Sampling Strategy: this index strategy seeks to build a representative portfolio that matches the risk and return characteristics of the Index in the most efficient way. A sub-fund using this strategy will typically hold only a subset of the securities included in the Index.

The anticipated level of tracking error of the Sub-fund will be up to 1% under normal market conditions.

The Sub-fund has been categorised as an ESG Promotion Strategy sub-fund in accordance with article 8 of the SFDR.

This is a capitalization class.

Only Authorised Participants may subscribe or redeem ETF Shares directly with the Company in the Primary Market, in accordance with the Prospectus. Persons who are not authorized participants may subscribe or redeem ETF Shares in the Secondary Market in accordance with the Prospectus.

#### Intended Retail Investor:

The Sub-fund is suitable for investors who look for long term investments and have a preference for sustainable ESG strategies. The investor must be able to accept a certain volatility and the possibility of losing a part of the invested amount. This product is for investors who meet the conditions for accessing the product in question (see prospectus) with any level of knowledge and experience. Investors should understand the product risks and only invest if they can bear potentially substantial losses.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The risk indicator assumes you keep the product for a minimum of 5 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back. The redemption price may, depending on the evolution of the net asset value, be higher or lower than the paid issue price.

Specific reasons, such as change restrictions or circumstances outside the control of the Depository Bank, may render impossible the transfer of redemption amount in the country where the redemption is requested.

In case of mass redemptions, the Management Company may decide to suspend the redemptions until it has sold the necessary assets.

We have classified this product as class 4 out of 7, which is a medium risk class.

You may request to redeem the units held at any moment, and on any business day, in accordance with the Prospectus. Any costs are shown under "Composition of costs" above.
