### WHAT IS THE PRODUCT?

#### Type:

Umbrella investment company with variable capital (société d'investissement à capital variable) incorporated as a public limited company (société anonyme) in the Grand Duchy of Luxembourg, qualifying as an undertaking for collective investment in transferable securities (UCITS) under Part I of the Luxembourg Law dated December 17, 2010.

#### Term:

This sub-fund is not subject to any fixed term. The SICAV's liquidation shall be decided by the general meeting of shareholders, in accordance with the applicable law and the Articles of Incorporation. The Company may also enter into liquidation by judicial decision according to the Law of December 17, 2010. The Board of Directors may decide to liquidate the sub-fund in case of extraordinary events such as changes in the political, economical or monetary situation or when the net asset of the sub-fund is less than a minimum level for the sub-fund to be operated in an economically efficient manner, as further described in the Prospectus.

#### Objectives:

INTERFUND BOND TACTICAL ALLOCATION, expressed in EURO, seeks to achieve capital appreciation over the recommended holding period by investing primarily in a diversified portfolio of debt and debt-related instruments issued by both governmental and non-governmental issuers (without limit of duration, currency).

The sub-fund will invest in a wide range of fixed income securities and financial derivative instruments with the aim of generating an absolute positive performance. The sub-fund is poised to take advantage of short-term market opportunities by shifting exposures based on short term market forecast or by taking a hedge against short term market risks.

The sub-fund has maximum flexibility to perform indirect investments through financial derivative instruments in a broad range of sectors and in any geographical region including emerging markets.

Indirect investments in Emerging Markets will not exceed 100% of the sub-fund's net assets.

The sub-fund may invest up to 40% of its net assets through the use of financial derivative instruments in Chinese corporate and government bonds denominated in onshore or offshore Renminbi.

The sub-fund may invest in bond linked unfunded Total Return Swaps.

The sub-fund may invest in credit default swaps and interest rate swaps and foreign exchange derivatives which may be used with a substantial level of gross leverage in order to generate the desired level of return.

The sub-fund may also use financial derivative instruments for taking long and short positions, which may increase its level of risk, as well as for hedging and efficient portfolio management purposes, which may contribute to reducing the sub-fund's level of risk.

The sub-fund may also directly invest its net assets as follows:

- up to 100% in debt securities issued by OECD countries or supranational entities with an investment grade rating;
- up to 50% in debt securities issued by corporation, other non-government issuers, governments and government related issuers located in both developed and emerging markets and denominated in global currencies with an investment grade rating .
- up to 10% in debt securities with a sub-investment grade rating;
- up to 10% (cumulatively) in asset backed securities (ABS) and mortgage backed securities (MBS);
- up to 10% (cumulatively) in contingent convertible bonds (CoCos), convertibles bond and structured bonds in any geographical region including Emerging Markets;
- up to 10% in units/shares of UCITS and/or other UCIs including ETFs.

The sub-fund may also invest up to 10% of its net assets in unrated debt securities.

The sub-fund may use financial derivative instruments for the purpose of risk hedging, efficient portfolio management and investment purposes.

The sub-fund is actively managed. The sub-fund is not managed in reference to a benchmark.

You may request to redeem the share held at any moment, in accordance with the Prospectus.

#### Intended Retail Investor:

The Sub-fund is suitable for investors who look for medium-term investments. The investor must be able to accept a certain volatility and the possibility of losing a part of the invested amount. This product is for investors who meet the conditions for accessing the product in question (see prospectus) with any level of knowledge and experience. Investors should understand the product risks and only invest if they can bear potentially substantial losses.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The risk indicator assumes you keep the product for a minimum of 4 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back. The redemption price may, depending on the evolution of the net asset value, be higher or lower than the paid issue price.

Specific reasons, such as change restrictions or circumstances outside the control of the Depositary Bank, may render impossible the transfer of redemption amount in the country where the redemption is requested.

In case of mass redemptions, the Management Company may decide to suspend the redemptions until it has sold the necessary assets.

We have classified this product as class 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact the capacity of the fund to pay you.
